A newly elected MEP will be invited to join the high-level policy debate where priorities for the next political mandate will be discussed with EU policymakers.

On the second day, the latest scientific evidence about the role of organic in achieving long-term food security will be presented, as will be opportunities for organic research & innovation in the new partnerships "AGROECOLOGY" and "FutureFoodS". In an interactive workshop, the participants will be able to share their expertise and thoughts about upcoming priorities for organic research & innovation that should be part of the new TP Organics Strategic Research & Innovation Agenda (SRIA) for Organics and Agroecology. This key advocacy document will be instrumental in advising the European Commission on what should be the priorities of the next EU R&I framework programme succeeding Horizon Europe (FP10). Bram Moeskops, Managing Director at FiBL Europe, Member of the TP Organics Steering Committee and Scientific Coordinator of the TP Organics SRIA will introduce the development process and the interactive workshop.
